Lecture 1

Microlocalization of sheaves

Abstract. This first talk is a survey talk with some historical comments and I refer to [Sc10] for a more detailed overview.

I will first explain the notions of Sato's hyperfunctions and microfunctions, at the origin of the story, and I will describe the Sato's microlocalization functor which was first motivated by problems of Analysis (see [SKK73]). Then I will briefly recall the main features of the microlocal theory of sheaves of [KS90] with emphasize on the functor μhom which will be the main tool for the second talk.

1.1 Generalized functions

In the sixties, people were used to work with various spaces of generalized functions constructed with the tools of functional analysis. Sato's construction of hyperfunctions in 59-60 is at the opposite of this practice: he uses purely algebraic tools and complex analysis. The importance of Sato's definition is twofold: first, it is purely algebraic (starting with the analytic object \mathcal{O}_X), and second it highlights the link between real and complex geometry. (See [Sa60] and see [Sc07] for an exposition of Sato's work.)

Consider first the case where M is an open subset of the real line \mathbb{R} and let X be an open neighborhood of M in the complex line \mathbb{C} satisfying $X \cap \mathbb{R} = M$. The space $\mathscr{B}(M)$ of hyperfunctions on M is given by

$$\mathscr{B}(M)=\mathscr{O}(X\setminus M)/\mathscr{O}(X).$$

It is easily proved, using the solution of the Cousin problem, that this space depends only on M, not on the choice of X, and that the correspondence $U \mapsto \mathcal{B}(U)$ (U open in M) defines a flabby sheaf \mathcal{B}_M on M.

With Sato's definition, the boundary values always exist and are no more a limit in any classical sense.

Example 1.1.1. (i) The Dirac function at 0 is

$$\delta(0) = \frac{1}{2i\pi} \left(\frac{1}{x - i0} - \frac{1}{x + i0} \right)$$

Indeed, if φ is a C^0 -function on \mathbb{R} with compact support, one has

$$\varphi(0) = \lim_{\varepsilon \to 0} \frac{1}{2i\pi} \int_{\mathbb{R}} \left(\frac{\varphi(x)}{x - i\varepsilon} - \frac{\varphi(x)}{x + i\varepsilon} \right) dx.$$

(ii) The holomorphic function $\exp(1/z)$ defined on $\mathbb{C} \setminus \{0\}$ has a boundary value as a hyperfunction (supported by $\{0\}$) not as a distribution.

On a real analytic manifold M of dimension n, the sheaf \mathscr{B}_M was originally defined as

$$\mathscr{B}_M = H_M^n(\mathscr{O}_X) \otimes \mathrm{or}_M$$

where X is a complexification of M and or_M is the orientation sheaf on M. It is shown that this object is concentrated in degree 0. Since X is oriented, Poincaré's duality gives the isomorphism $\operatorname{D}'_X(\mathbb{C}_M) \simeq \operatorname{or}_M[-n]$ (see (1.2.1) below for the definition of D'_M). An equivalent definition of hyperfunctions is thus given by

(1.1.1)
$$\mathscr{B}_M = R \mathscr{H}om_{\mathbb{C}_X}(\mathcal{D}'_X(\mathbb{C}_M), \mathscr{O}_X).$$

Let us define the notion of "boundary value" in this settings. Consider a subanalytic open subset Ω of X and denote by $\overline{\Omega}$ its closure. Assume that:

$$\left\{ \begin{array}{l} \mathrm{D}_X'(\mathbb{C}_\Omega) \simeq \mathbb{C}_{\overline{\Omega}}, \\ M \subset \overline{\Omega}. \end{array} \right.$$

The morphism $\mathbb{C}_{\overline{\Omega}} \to \mathbb{C}_M$ defines by duality the morphism $\mathrm{D}'_X(\mathbb{C}_M) \to \mathrm{D}'_X(\mathbb{C}_{\overline{\Omega}}) \simeq \mathbb{C}_{\Omega}$. Applying the functor RHom (\bullet, \mathscr{O}_X) , we get the boundary value morphism

$$(1.1.2) b: \mathscr{O}(\Omega) \to \mathscr{B}(M).$$

When considering operations on hyperfunctions such as integral transforms, one is naturally lead to consider more general sheaves of generalized functions such as $R\mathscr{H}om(G, \mathscr{O}_X)$ where G is a constructible sheaf. We shall come back on this point later.

Similarly as in dimension one, one can represent the sheaf \mathscr{B}_M by using Čech cohomology of coverings of $X \setminus M$. For example, let X be a Stein open subset of \mathbb{C}^n and set $M = \mathbb{R}^n \cap X$. Denote by x the coordinates on \mathbb{R}^n and by x+iy the coordinates on \mathbb{C}^n . One can recover $\mathbb{C}^n \setminus \mathbb{R}^n$ by n+1 open half-spaces $V_i = \langle y, \xi_i \rangle > 0$ $(i = 1, \ldots, n+1)$. For $J \subset \{1, \ldots, n+1\}$ set $V_J = \bigcap_{j \in J} V_j$. Assuming n > 1, we have the isomorphism $H^n_M(X; \mathscr{O}_X) \simeq H^{n-1}(X \setminus M; \mathscr{O}_X)$. Therefore, setting $U_J = V_J \cap X$, one has

$$\mathscr{B}(M) \simeq \sum_{|J|=n} \mathscr{O}_X(U_J) / \sum_{|K|=n-1} \mathscr{O}_X(U_K).$$

On a real analytic manifold M, any hyperfunction $u \in \Gamma(M; \mathcal{B})$ is a (non unique) sum of boundary values of holomorphic functions defined in tubes with edge M. Such a decomposition leads to the so-called Edge of the Wedge theorem and was intensively studied in the seventies (see [Mr67, BI73]).

Then comes naturally the following problem: how to recognize the directions associated with these tubes? The answer is given by the Sato's microlocalization functor.

1.2 Microlocalization

Unless otherwise specified, all manifolds are real, say of class C^{∞} and **k** denotes a commutative unital ring with finite global homological dimension.

We denote by \mathbf{k}_M the constant sheaf on M with stalk \mathbf{k} , by $\mathsf{D}^{\mathrm{b}}(\mathbf{k}_M)$ the bounded derived category of sheaves of \mathbf{k} -modules on M and by $\mathsf{D}^{\mathrm{b}}_{\mathrm{cc}}(\mathbf{k}_M)$ the full triangulated subcategory of $\mathsf{D}^{\mathrm{b}}(\mathbf{k}_M)$ consisting of cohomologically constructible objects. If M is real analytic, we denote by $\mathsf{D}^{\mathrm{b}}_{\mathbb{R}\text{-c}}(\mathbf{k}_M)$ the triangulated category of \mathbb{R} -constructible sheaves.

We denote by ω_M the dualizing complex on M. Then $\omega_M \simeq \operatorname{or}_M [\dim M]$ where or_M is the orientation sheaf and $\dim M$ the dimension of M. We shall use the duality functors

(1.2.1)
$$D'_{M}F = R\mathscr{H}om(F, \mathbf{k}_{M}), \quad D_{M}F = R\mathscr{H}om(F, \omega_{M}).$$

For a locally closed subset A of M, we denote by $\mathbf{k}_{M,A}$ the sheaf which is the constant sheaf on A with stalk \mathbf{k} and which is 0 on $M \setminus A$. If there is no risk of confusion, we simply denote it by \mathbf{k}_A .

Fourier-Sato transform

The classical Fourier transform interchanges (generalized) functions on a vector space V and (generalized) functions on the dual vector space V^* . The


idea of extending this formalism to sheaves, hence to replacing an isomorphism of spaces with an equivalence of categories, seems to have appeared first in Mikio Sato's construction of microfunctions in the 70's.

Let $\tau: E \to M$ be a finite dimensional real vector bundle over a real manifold M with fiber dimension n and let $\pi: E^* \to M$ be the dual vector bundle. Denote by p_1 and p_2 the first and second projection defined on $E \times_M E^*$, and define:

$$P = \{(x, y) \in E \times_M E^*; \langle x, y \rangle \ge 0\},$$

$$P' = \{(x, y) \in E \times_M E^*; \langle x, y \rangle \le 0\}.$$

Consider the diagram:



Denote by $\mathsf{D}^{\mathsf{b}}_{\mathbb{R}^+}(\mathbf{k}_E)$ the full triangulated subcategory of $\mathsf{D}^{\mathsf{b}}(\mathbf{k}_E)$ consisting of conic sheaves, that is, objects objects with locally constant cohomology on the orbits of \mathbb{R}^+ .

Definition 1.2.1. Let $F \in \mathsf{D}^{\mathsf{b}}_{\mathbb{R}^+}(\mathbf{k}_E), G \in \mathsf{D}^{\mathsf{b}}_{\mathbb{R}^+}(\mathbf{k}_{E^*})$. One sets:

$$F^{\wedge} = Rp_{2!}(p_1^{-1}F)_{P'} \simeq Rp_{2*}(R\Gamma_P p_1^{-1}F),$$

$$G^{\vee} = Rp_{1*}(R\Gamma_{P'}p_2^!G) \simeq Rp_{1!}(p_2^!G)_P.$$

The main result of the theory is the following.

Theorem 1.2.2. The two functors $(\cdot)^{\wedge}$ and $(\cdot)^{\vee}$ are inverse to each other, hence define an equivalence of categories $\mathsf{D}^{\mathsf{b}}_{\mathbb{R}^+}(\mathbf{k}_E) \simeq \mathsf{D}^{\mathsf{b}}_{\mathbb{R}^+}(\mathbf{k}_{E^*})$.

Example 1.2.3. (i) Let γ be a closed proper convex cone in E with $M \subset \gamma$. Then:

$$(\mathbf{k}_{\gamma})^{\wedge} \simeq \mathbf{k}_{\mathrm{Int}\gamma^{\circ}}.$$

Here γ° is the polar cone to γ , a closed convex cone in E^* and $\mathrm{Int}\gamma^{\circ}$ denotes its interior.

(ii) Let γ be an open convex cone in E. Then:

$$(\mathbf{k}_{\gamma})^{\wedge} \simeq \mathbf{k}_{\gamma^{\circ a}} \otimes \operatorname{or}_{E^*/M} [-n].$$

Here $\lambda^a = -\lambda$, the image of λ by the antipodal map.

(iii) Let (x) = (x', x'') be coordinates on \mathbb{R}^n with $(x') = (x_1, \dots, x_p)$ and $(x'') = (x_{p+1}, \dots, x_n)$. Denote by (y) = (y', y'') the dual coordinates on $(\mathbb{R}^n)^*$. Set

$$\gamma = \{x; x'^2 - x''^2 \ge 0\}, \quad \lambda = \{y; y'^2 - y''^2 \le 0\}.$$

Then $(\mathbf{k}_{\gamma})^{\wedge} \simeq \mathbf{k}_{\lambda}[-p]$. (See [KS97].)

Specialization

Let $\iota: N \hookrightarrow M$ be the embedding of a closed submanifold N of M. Denote by $\tau_M: T_NM \to M$ the normal bundle to N.

If F is a sheaf on M, its restriction to N, denoted $F|_N$, may be viewed as a global object, namely the direct image by τ_M of a sheaf $\nu_M F$ on $T_N M$, called the specialization of F along N. Intuitively, $T_N M$ is the set of light rays issued from N in M and the germ of $\nu_N F$ at a normal vector $(x; v) \in T_N M$ is the germ at x of the restriction of F along the light ray v.

One constructs a new manifold M_N , called the normal deformation of M along N, together with the maps

$$(1.2.2) \quad T_N M \xrightarrow{s} \widetilde{M}_N \xleftarrow{j} \Omega , \quad t \colon \widetilde{M}_N \to \mathbb{R}, \ \Omega = \{t^{-1}(\mathbb{R}_{>0})\}$$

$$\downarrow^p \qquad p \qquad p$$

$$N \xrightarrow{t} M$$

with the following properties. Locally, after choosing a local coordinate system (x', x'') on M such that $N = \{x' = 0\}$, we have $M_N = M \times \mathbb{R}$, $t : M_N \to \mathbb{R}$ is the projection, $\Omega = \{(x; t) \in M \times \mathbb{R}; t > 0\}$, p(x', x'', t) = (tx', x''), $T_N M = \{t = 0\}$.

Let $S \subset M$ be a locally closed subset. The Whitney normal cone $C_N(S)$ is a closed conic subset of T_NM given by

$$C_N(S) = \overline{\widetilde{p}^{-1}(S)} \cap T_N M$$

where, for a set A, \overline{A} denotes the closure of A.

One defines the specialization functor

$$\nu_N \colon \mathsf{D}^\mathrm{b}(\mathbf{k}_M) \to \mathsf{D}^\mathrm{b}(\mathbf{k}_{T_N M})$$

by a similar formula, namely:

$$\nu_N F := s^{-1} j_* \widetilde{p}^{-1} F.$$

Clearly, $\nu_N F \in \mathsf{D}^{\mathsf{b}}_{\mathbb{R}^+}(\mathbf{k}_{T_N M})$, that is, $\nu_N F$ is a conic sheaf for the \mathbb{R}^+ -action on $T_N M$. Moreover,

$$R\tau_{M*}\nu_N F \simeq \nu_N F|_N \simeq F|_N$$
.

For an open cone $V \subset T_N M$, one has

$$H^{j}(V; \nu_{N}F) \simeq \varinjlim_{U} H^{j}(U; F)$$

where U ranges through the family of open subsets of M such that

$$C_N(M \setminus U) \cap V = \emptyset.$$

Microlocalization

Denote by $\pi_M \colon T_N^*M \to M$ the conormal bundle to N in M, that is, the dual bundle to $\tau_M \colon T_NM \to M$.

If F is a sheaf on M, the sheaf of sections of F supported by N, denoted $R\Gamma_N F$, may be viewed as a global object, namely the direct image by π_M of a sheaf $\mu_M F$ on T_N^*M . Intuitively, T_N^*M is the set of "walls" (half-spaces) in M passing through N and the germ of $\mu_N F$ at a conormal vector $(x; \xi) \in T_N^*M$ is the germ at x of the sheaf of sections of F supported by closed tubes with edge N and which are almost the half-space associated with ξ .

More precisely, the microlocalization of F along N, denoted $\mu_N F$, is the Fourier-Sato transform of $\nu_N F$, hence is an object of $\mathsf{D}^{\mathsf{b}}_{\mathbb{R}^+}(\mathbf{k}_{T_N^*M})$. It satisfies:

$$R\pi_{M*}\mu_N F \simeq \mu_N F|_N \simeq R\Gamma_N F.$$

For a convex open cone $V \subset T_N^*M$, one has

$$H^{j}(V; \mu_{N}F) \simeq \underset{U,Z}{\lim} H^{j}_{U \cap Z}(U; F),$$

where U ranges over the family of open subsets of M such that $U \cap M = \pi_M(V)$ and Z ranges over the family of closed subsets of M such that $C_M(Z) \subset V^{\circ}$ where V° is the polar cone to V.

Back to hyperfunctions

Assume now that M is a real analytic manifold and X is a complexification of M. First notice the isomorphisms

$$M\times_X T^*X\simeq \mathbb{C}\otimes_{\mathbb{R}} T^*M\simeq T^*M\oplus \sqrt{-1}T^*M.$$

One deduces the isomorphism

$$(1.2.3) T_M^* X \simeq \sqrt{-1} T^* M.$$

The sheaf \mathscr{C}_M on T_M^*X of Sato's microfunction (see [SKK73]) is defined as

$$\mathscr{C}_M := \mu_M(\mathscr{O}_X) \otimes \pi_M^{-1} \omega_M.$$

It is shown that this object is concentrated in degree 0. Therefore, we have an isomorphism

spec:
$$\mathscr{B}_M \xrightarrow{\sim} \pi_{M*}\mathscr{C}_M$$

and Sato defines the analytic wave front set of a hyperfunction $u \in \Gamma(M; \mathscr{B}_M)$ as the support of $\operatorname{spec}(u) \in \Gamma(T_M^*X; \mathscr{C}_M)$.

Consider a closed convex proper cone $Z \subset T_M^*X$ which contains the zerosection M. Then $\operatorname{spec}(u) \subset Z$ if and only if u is the boundary value of a holomorphic function defined in a tuboid U with profile the interior of the polar tube to Z^a (where Z^a is the image of Z by the antipodal map), that is, satisfying

$$C_M(X \setminus U) \cap \operatorname{Int} Z^{\circ a} = \emptyset.$$

Moreover, the sheaf \mathscr{C}_M is conically flabby. Therefore, any hyperfunction may be decomposed as a sum of boundary values of holomorphic functions f_i 's defined in suitable tuboids U_i and if we have hyperfunctions u_i (i = 1, ..., N) satisfying $\sum_j u_j = 0$, there exist hyperfunctions u_{ij} (i, j = 1, ..., N) such that

$$u_{ij} = -u_{ji}, \quad u_i = \sum_j u_{ij} \text{ and } \operatorname{spec}(u_{ij}) \subset \operatorname{spec}(u_i) \cap \operatorname{spec}(u_j).$$

When translating this result in terms of boundary values of holomorphic functions, we get the so-called "Edge of the wedge theorem", already mentioned.

Sato's introduction of the sheaf \mathcal{C}_M was the starting point of an intense activity in the domain of linear partial differential equations after Hörmander adapted Sato's ideas to classical analysis with the help of the (usual) Fourier transform. See [Ho83] and also [BI73, Sj82] for related constructions. Note that the appearance of $\sqrt{-1}$ in the usual Fourier transform may be understood as following from the isomorphism (1.2.3).

1.3 Microsupport

The microsupport of sheaves has been introduced in [KS82] and developed in [KS85, KS90]. Roughly speaking, the microsupport of F describes the codirections of non propagation of F. The idea of microsupport takes its origin in the study of linear PDE and particularly in the study of hyperbolic systems.

Definition 1.3.1. Let $F \in \mathsf{D}^{\mathsf{b}}(\mathbf{k}_M)$ and let $p \in T^*M$. One says that $p \notin \mathsf{SS}(F)$ if there exists an open neighborhood U of p such that for any $x_0 \in M$ and any real C^1 -function φ on M defined in a neighborhood of x_0 with $(x_0; d\varphi(x_0)) \in U$, one has $(\mathsf{R}\Gamma_{\{x:\varphi(x)>\varphi(x_0)\}}F)_{x_0} \simeq 0$.

In other words, $p \notin SS(F)$ if the sheaf F has no cohomology supported by "half-spaces" whose conormals are contained in a neighborhood of p.

- By its construction, the microsupport is \mathbb{R}^+ -conic, that is, invariant by the action of \mathbb{R}^+ on T^*M .
- $SS(F) \cap T_M^*M = \pi_M(SS(F)) = Supp(F).$
- The microsupport satisfies the triangular inequality: if $F_1 \to F_2 \to F_3 \xrightarrow{+1}$ is a distinguished triangle in $\mathsf{D^b}(\mathbf{k}_M)$, then $\mathsf{SS}(F_i) \subset \mathsf{SS}(F_j) \cup \mathsf{SS}(F_k)$ for all $i, j, k \in \{1, 2, 3\}$ with $j \neq k$.

Example 1.3.2. (i) If F is a non-zero local system on M and M is connected, then $SS(F) = T_M^*M$.

- (ii) If N is a closed submanifold of M and $F = \mathbf{k}_N$, then $SS(F) = T_N^* M$, the conormal bundle to N in M.
- (iii) Let φ be a C¹-function such that $d\varphi(x) \neq 0$ whenever $\varphi(x) = 0$. Let $U = \{x \in M; \varphi(x) > 0\}$ and let $Z = \{x \in M; \varphi(x) \geq 0\}$. Then

$$SS(\mathbf{k}_U) = U \times_M T_M^* M \cup \{(x; \lambda d\varphi(x)); \varphi(x) = 0, \lambda \leq 0\},$$

$$SS(\mathbf{k}_Z) = Z \times_M T_M^* M \cup \{(x; \lambda d\varphi(x)); \varphi(x) = 0, \lambda \geq 0\}.$$

For a precise definition of being co-isotropic (one also says involutive), we refer to [KS90, Def. 6.5.1].

Theorem 1.3.3. Let $F \in D^b(\mathbf{k}_M)$. Then its microsupport SS(F) is coisotropic.

Assume now that X is a complex manifold that we identify with its real underlying manifold. The link between the microsupport of sheaves and the characteristic variety of coherent \mathscr{D} -modules is given by:

Theorem 1.3.4. Let \mathcal{M} be a coherent \mathcal{D} -module. Then $SS(Sol(\mathcal{M})) = char(\mathcal{M})$.

The inclusion $SS(Sol(\mathcal{M})) \subset char(\mathcal{M})$ is the most useful in practice. Its proof only makes use of the Cauchy-Kowalevsky theorem in its precise form given by Petrovsky and Leray (see [Ho83, § 9.4]) and of purely algebraic arguments. As a corollary of Theorems 1.3.3 and 1.3.4, one recovers the fact that the characteristic variety of a coherent \mathcal{D} -module is co-isotropic, a theorem of [SKK73] which also have a prurely algebraic proof due to Gabber [Ga81].

1.4 The functor μhom

We denote by $\delta \colon M \to M \times M$ the diagonal embedding and we set $\Delta = \delta(M)$. For short, we also denote by δ the isomorphism

$$\delta \colon T^*M \xrightarrow{\sim} T^*_{\Delta}(M \times M), \quad (x;\xi) \mapsto (x,x;\xi,-\xi).$$

Let us briefly recall the main properties of the functor μhom , a variant of Sato's microlocalization functor.

$$\mu hom : \mathsf{D}^{\mathrm{b}}(\mathbf{k}_{M})^{\mathrm{op}} \times \mathsf{D}^{\mathrm{b}}(\mathbf{k}_{M}) \to \mathsf{D}^{\mathrm{b}}(\mathbf{k}_{T^{*}M}),$$

 $\mu hom(G, F) = \delta^{-1} \mu_{\Delta} \mathcal{R} \mathcal{H} om(q_{2}^{-1}G, q_{1}^{!}F)$

where q_i (i = 1, 2) denotes the *i*-th projection on $M \times M$. Note that

$$R\pi_{M*}\mu hom(G,F) \simeq R\mathscr{H}om(G,F),$$

 $\mu hom(\mathbf{k}_N,F) \simeq \mu_N(F) \text{ for } N \text{ a closed submanifold of } M,$
 $\operatorname{supp} \mu hom(G,F) \subset SS(G) \cap SS(F),$
 $\mu hom(G,F) \simeq \mu_{\Delta}(F \boxtimes DG) \text{ if } G \text{ is constructible.}$

In some sense, μhom is the sheaf of microlocal morphisms. More precisely, for $p \in T^*M$, we have;

$$H^0\mu hom(G,F)_p \simeq \operatorname{Hom}_{\mathsf{D}^{\mathrm{b}}(\mathbf{k}_M:p)}(G,F)$$

where the category $\mathsf{D}^{\mathsf{b}}(\mathbf{k}_{M};p)$ is the localization of $\mathsf{D}^{\mathsf{b}}(\mathbf{k}_{M})$ by the subcategory of sheaves whose microsupport does not contain p.

There is an interesting phenomena which holds with μhom and not with R $\mathscr{H}om$. Indeed, assume M is real analytic. Then, although the category $\mathsf{D}^b_{\mathbb{R}\text{-c}}(\mathbf{k}_M)$ of constructible sheaves does not admit a Serre functor, it admits

a kind of microlocal Serre functor, as shown by the isomorphism, functorial wrt F and G (see [KS90, Prop. 8.4.14]):

$$D_{T^*M}\mu hom(F,G) \simeq \mu hom(G,F)^a \otimes \pi_M^{-1}\omega_M,$$

where $(\cdot)^a$ stands for the direct image by the antipodal map a. This confirms the fact that to fully understand constructible sheaves, it is natural to look at them microlocally, that is, in T^*M . This is also in accordance with the "philosophy" of Mirror Symmetry which interchanges the category of coherent \mathcal{O}_X -modules on a complex manifold X with the Fukaya category on a symplectic manifold Y. In case of $Y = T^*M$, the Fukaya category is equivalent to the category of \mathbb{R} -constructible sheaves on M, according to Nadler-Zaslow [Na09, NZ09].

1.5 An application: elliptic pairs

Denote by \dot{T}^*M the set $T^*M \setminus T_M^*M$ and denote by $\dot{\pi}_M$ the restriction of $\pi_M : T^*M \to M$ to \dot{T}^*M . If $H \in \mathsf{D}^\mathsf{b}_{\mathbb{R}^+}(\mathbf{k}_{T^*M})$ is a conic sheaf on T^*M , there is the Sato's distinguished triangle

$$R\pi_{M!}H \to R\pi_*H \to R\dot{\pi}_{M*}H \xrightarrow{+1}$$

Applying this result with $H = \mu hom(G, F)$ and assuming G is constructible, we get the distinguished triangle

$$D'G \otimes F \to R \mathcal{H}om(G, F) \to R\dot{\pi}_{M*}\mu hom(G, F).$$

Theorem 1.5.1. (The Petrowsky theorem for sheaves.) Assume that G is constructible and $SS(G) \cap SS(F) \subset T_M^*M$. Then the natural morphism

$$R\mathscr{H}om(G, \mathbf{k}_M) \otimes F \to R\mathscr{H}om(G, F)$$

is an isomorphism.

Let us apply this result when X is a complex manifold. For $G \in \mathsf{D}^{\mathsf{b}}_{\mathbb{R}\text{-c}}(\mathbb{C}_X)$, set

$$\mathscr{A}_G = \mathscr{O}_X \otimes G, \quad \mathscr{B}_G := R \mathscr{H}om(D'G, \mathscr{O}_X).$$

Note that if X is the complexification of a real analytic manifold M and we choose $G = \mathbb{C}_M$, we recover the sheaf of real analytic functions and the sheaf of hyperunctions:

$$\mathscr{A}_{\mathbb{C}_M} = \mathscr{A}_M, \quad \mathscr{B}_{\mathbb{C}_M} = \mathscr{B}_M.$$

Now let $\mathcal{M} \in \mathsf{D}^{\mathsf{b}}_{\mathsf{coh}}(\mathcal{D}_X)$. According to [ScSn94], one says that the pair (G, \mathcal{M}) is elliptic if $\mathsf{char}(\mathcal{M}) \cap \mathsf{SS}(G) \subset T_X^*X$.

Corollary 1.5.2. [ScSn94] Let (\mathcal{M}, G) be an elliptic pair.

(a) We have the canonical isomorphism:

(b) Assume moreover that $\mathrm{Supp}(\mathcal{M})\cap\mathrm{Supp}(G)$ is compact. Then the cohomology of the complex $\mathrm{RHom}_{\mathscr{D}_X}(\mathcal{M},\mathscr{A}_G)$ is finite dimensional.

To prove the part (b) of the corollary, one represents the left hand side of the global sections of (1.5.1) by a complex of topological vector spaces of type DFN and the right hand side by a complex of topological vector spaces of type FN.

Lecture 2

Hochschild homology and microlocal Euler classes

Abstract. This is a joint work with Masaki Kashiwara announced in [KS12]. On a complex manifold (X, \mathcal{O}_X) , the Hochschild homology is a powerful tool to construct characteristic classes of coherent modules and to get index theorems. Here, I will show how to adapt this formalism to a wide class of sheaves on a real manifold M by using the functor μhom of microlocalization. This construction applies in particular to constructible sheaves on real manifolds and \mathcal{D} -modules on complex manifolds, or more generally to elliptic pairs.

2.1 Hochschild homology on complex manifolds

Hochschild homology of *⊙*-modules has given rise to a vast literature. Let us quote in particular [Hu06, Ca05, Ca07, Ra08].

Consider a complex manifold (X, \mathcal{O}_X) and denote by ω_X^{hol} the dualizing complex of X in the category of \mathcal{O}_X -modules, that is, $\omega_X^{\text{hol}} = \Omega_X [d_X]$, where d_X is the complex dimension of X and Ω_X is the sheaf of holomorphic forms of degree d_X . We shall use the classical six operations for \mathscr{O} -modules, f^* , Rf_* , $f^!$, $Rf_!$, $\overset{L}{\otimes}_{\mathscr{O}}$ and $R\mathscr{H}om_{\mathscr{O}}$. In particular we have the two duality functors

$$\begin{aligned} \mathbf{D}_{\mathscr{O}}'(\,\bullet\,) &= \mathbf{R}\mathscr{H}om_{\,\mathscr{O}_X}(\,\bullet\,,\mathscr{O}_X),\\ \mathbf{D}_{\mathscr{O}}(\,\bullet\,) &= \mathbf{R}\mathscr{H}om_{\,\mathscr{O}_X}(\,\bullet\,,\omega_X) \end{aligned}$$

as well as the external product that we denote by $\stackrel{\mathbf{L}}{\boxtimes}_{\mathscr{O}}$. Denote by $\delta \colon X \hookrightarrow$

 $X \times X$ the diagonal embedding and let $\Delta = \delta(X)$. We set

$$(2.1.1) \ \mathscr{O}_{\Delta} := \delta_* \mathscr{O}_X, \quad \omega_X^{\mathrm{hol}, \otimes -1} := \mathrm{D}'_{\mathscr{O}} \omega_X^{\mathrm{hol}}, \quad \omega_\Delta^{\mathrm{hol}, \otimes -1} := \delta_* \omega_X^{\mathrm{hol}, \otimes -1}.$$

It is well-known that

$$(2.1.2) \qquad \qquad \omega_{\Delta}^{\mathrm{hol},\otimes-1} \simeq \mathrm{R} \mathscr{H}\!\mathit{om}_{\mathscr{O}_{X\times X}}(\mathscr{O}_{\Delta},\mathscr{O}_{X\times X}).$$

The Hochschild homology of \mathcal{O}_X is usually defined by

$$\mathscr{HH}(\mathscr{O}_X) = \delta^* \delta_* \mathscr{O}_X.$$

For a closed subset S of X, we set:

(2.1.4)
$$\mathbb{HH}_{S}^{0}(\mathscr{O}_{X}) = H^{0}(X; R\Gamma_{S}\mathscr{H}\mathscr{H}(\mathscr{O}_{X})).$$

There are natural isomorphisms

$$\delta_* \mathcal{HH}(\mathcal{O}_X) \simeq \mathcal{O}_{\Delta} \overset{\mathrm{L}}{\otimes}_{\mathcal{O}_{X \times X}} \mathcal{O}_{\Delta},$$
$$\simeq \mathrm{R} \mathcal{H}om_{\mathcal{O}_{X \times X}} \left(\omega_{\Delta}^{\mathrm{hol}, \otimes -1}, \mathcal{O}_{\Delta}\right).$$

If $\mathscr{F} \in \mathsf{D}^{\mathsf{b}}_{\mathsf{coh}}(\mathscr{O}_X)$, the evaluation morphism $\mathscr{F} \overset{\mathsf{L}}{\otimes_{\mathscr{O}}} \mathsf{D}'_{\mathscr{O}}\mathscr{F} \to \mathscr{O}_X$ gives by adjunction the morphism $\mathscr{F} \overset{\mathsf{L}}{\boxtimes}_{\mathscr{O}} \mathsf{D}'_{\mathscr{O}}\mathscr{F} \to \mathscr{O}_{\Delta}$. By duality over $\mathscr{O}_{X \times X}$ and using (2.1.2) one gets the morphism $\omega_{\Delta}^{\mathsf{hol},\otimes^{-1}} \to \mathscr{F} \overset{\mathsf{L}}{\boxtimes}_{\mathscr{O}} \mathsf{D}'_{\mathscr{O}}\mathscr{F}$. To summarize, we have the morphisms

$$(2.1.5) \qquad \qquad \omega_{\Delta}^{\text{hol},\otimes -1} \to \mathscr{F} \stackrel{\mathcal{L}}{\boxtimes}_{\mathscr{O}} \mathcal{D}_{\mathscr{O}}' \mathscr{F} \to \mathscr{O}_{\Delta}.$$

The composition of the morphisms in (2.1.5) defines the Hochschild class of \mathscr{F} :

$$\mathrm{hh}_{\mathscr{O}}(\mathscr{F}) \in \mathbb{HH}^0_{\mathrm{supp}(\mathscr{F})}(\mathscr{O}_X).$$

One can compose Hochschild homology and the Hochschild class commutes with the composition of kernels. More precisely, consider complex manifolds X_i (i = 1, 2, 3).

- We write $X_{ij} := X_i \times X_j$ $(1 \le i, j \le 3), X_{123} = X_1 \times X_2 \times X_3, X_{1223} = X_1 \times X_2 \times X_2 \times X_3$, etc.
- We denote by q_i the projection $X_{ij} \to X_i$ or the projection $X_{123} \to X_i$ and by q_{ij} the projection $X_{123} \to X_{ij}$.

Let $K_{ij} \in \mathsf{D}^{\mathsf{b}}_{\mathsf{coh}}(\mathscr{O}_{X_{ij}})$ (i = 1, 2, j = i + 1). One sets

$$K_{12} \circ K_{23} = \operatorname{R} q_{13!} (q_{12}^* K_{12} \overset{\operatorname{L}}{\otimes}_{\mathscr{O}_{X_{123}}} q_{23}^* K_{23})$$

Theorem 2.1.1. (a) There is a natural morphism

$$\mathscr{HH}(\mathscr{O}_{X_{12}}) \underset{2}{\circ} \mathscr{HH}(\mathscr{O}_{X_{23}}) \to \mathscr{HH}(\mathscr{O}_{X_{13}}).$$

(b) Let $S_{ij} \subset X_{ij}$ be a closed subset (i = 1, 2, j = i + 1). Assume that q_{13} is proper over $S_{12} \times_{X_2} S_{23}$ and set $S_{13} = q_{13}(S_{12} \times_{X_2} S_{23})$. Then the morphism above induces a map

$$\circ \colon \mathbb{HH}^0_{S_{12}}(\mathscr{O}_{X_{12}}) \otimes \mathbb{HH}^0_{S_{23}}(\mathscr{O}_{X_{23}}) \to \mathbb{HH}^0_{S_{13}}(\mathscr{O}_{X_{13}}).$$

(c) Let K_{ij} be as above and assume that $\operatorname{supp}(K_{12}) \subset S_{ij}$. Set $K_{13} = K_{12} \circ K_{23}$. Then $K_{13} \in \mathsf{D}^{\mathsf{b}}_{\operatorname{coh}}(\mathscr{O}_{X_{13}})$ and $\operatorname{hh}_{\mathscr{O}}(K_{13}) = \operatorname{hh}_{\mathscr{O}}(K_{12}) \circ \operatorname{hh}_{\mathscr{O}}(K_{23})$ in $\mathbb{HH}^0_{S_{13}}(\mathscr{O}_{X_{13}})$.

This theorem shows in particular that the Hochschild class commutes with external product, inverse image and proper direct image.

Theorem 2.1.1 seems to be well-known from the specialists although it is difficult to find a precise statement (see however [Ca07, Ra10]). The construction of the Hochschild homology as well as Theorem 2.1.1 (including complete proofs) have been extended when replacing \mathcal{O}_X with a so-called DQ-algebroid stack \mathcal{A}_X in [KS12b].

Coming back to \mathcal{O}_X -modules, the Hodge cohomology of \mathcal{O}_X is given by:

(2.1.6)
$$\mathcal{HD}(\mathscr{O}_X) := \bigoplus_{i=0}^{d_X} \Omega_X^i[i], \text{ an object of } \mathsf{D}^{\mathrm{b}}(\mathscr{O}_X).$$

There is a commutative diagram constructed by Kashiwara in [Ka91] in which α_X is the HKR (Hochschild-Kostant-Rosenberg) isomorphism and β_X is a kind of dual HKR isomorphism:

$$\begin{array}{ccc}
\delta^* \delta_* \mathscr{O}_X & \xrightarrow{\sim} & \delta^! \delta_! \omega_X^{\text{hol}} \\
\alpha_X \middle| \sim & \sim \middle| \beta_X \\
\mathcal{H} \mathcal{D}(\mathscr{O}_X) & \xrightarrow{\tau} & \mathcal{H} \mathcal{D}(\mathscr{O}_X).
\end{array}$$

If $\mathscr{F} \in \mathsf{D}^{\mathsf{b}}_{\mathsf{coh}}(\mathscr{O}_X)$, the Chern character of \mathscr{F} is the image by α_X of $\mathsf{hh}_{\mathscr{O}}(\mathscr{F})$.

In [Ka91] Kashiwara made the conjecture that the arrow τ making the diagram commutative is given by the cup product by the Todd class of X. This conjecture has recently been proved by Ramadoss [Ra08] in the algebraic case and Grivaux [Gr09] in the analytic case (and with a very simple proof). Since the morphism β_X commutes with proper direct images, we get a new and functorial approach to the Hirzebruch-Riemann-Roch-Grothendieck theorem.

2.2 Hochschild homology for sheaves

We keep the notations of Lecture I. In particular ω_M denotes the dualizing complex on M and D'_M is the duality functor. We set

$$(2.2.1) \qquad \omega_{\Delta} := \delta_* \omega_M, \quad \omega_M^{\otimes -1} := \mathcal{D}_M' \omega_M, \quad \omega_{\Delta}^{\otimes -1} := \delta_* \omega_M^{\otimes -1},$$

Let M_i (i = 1, 2, 3) be manifolds.

- For short, we write as above $M_{ij} := M_i \times M_j$ $(1 \le i, j \le 3), M_{123} = M_1 \times M_2 \times M_3$, etc.
- We will often write for short \mathbf{k}_i instead of \mathbf{k}_{M_i} and \mathbf{k}_{Δ_i} instead of $\mathbf{k}_{\Delta_{M_i}}$, π_i instead of π_{M_i} , etc.
- We denote by q_i the projection $M_{ij} \to M_i$ or the projection $M_{123} \to M_i$ and by q_{ij} the projection $M_{123} \to M_{ij}$. Similarly, we denote by p_i the projection $T^*M_{ij} \to T^*M_i$ or the projection $T^*M_{123} \to T^*M_i$ and by p_{ij} the projection $T^*M_{123} \to T^*M_{ij}$.
- We also need to introduce the maps p_{j^a} or p_{ij^a} , the composition of p_j or p_{ij} and the antipodal map on T^*M_j .

We consider the operations of composition of kernels. For $K_{ij} \in \mathsf{D}^{\mathsf{b}}(\mathbf{k}_{M_{ij}})$ (i = 1, 2, j = i + 1), we set

$$\begin{array}{lcl} K_1 \underset{2}{\circ} K_2 &:= & \mathrm{R} q_{13!} \delta_2^{-1} (K_1 \boxtimes K_2) \simeq \mathrm{R} q_{13!} (q_{12}^{-1} K_1 \otimes q_{23}^{-1}), \\ K_1 \underset{2}{*} K_2 &:= & \mathrm{R} q_{13*} \big(\delta_2^! (K_1 \boxtimes K_2) \otimes q_2^{-1} \omega_2 \big). \end{array}$$

We have a natural morphism $K_1 \circ K_2 \to K_1 * K_2$. It is an isomorphism if $p_{12^a}^{-1}SS(K_1) \cap p_{23^a}^{-1}SS(K_2) \to T^*M_{13}$ is proper.

We also define the composition of kernels on cotangent bundles. For $L_i \in \mathsf{D^b}(\mathbf{k}_{T^*_{M_{ij}}})$ $(i=1,2,\,j=i+1),$ we set

$$L_1 \stackrel{a}{\circ} L_2 := Rp_{13^a!}(p_{12^a}^{-1}L_1 \otimes p_{23^a}^{-1}L_2).$$

For $K_1, F_1 \in \mathsf{D^b}(\mathbf{k}_{M_{12}})$ and $K_2, F_2 \in \mathsf{D^b}(\mathbf{k}_{M_{23}})$ there exists a canonical morphism:

(2.2.2)
$$\mu hom(K_1, F_1) \stackrel{a}{\underset{2}{\circ}} \mu hom(K_2, F_2) \to \mu hom(K_1 \underset{2}{*} K_2, F_1 \underset{2}{\circ} F_2).$$

We also define the corresponding operations for subsets of cotangent bundles. Let $A \subset T^*M_{12}$ and $B \subset T^*M_{23}$. We set $A \overset{a}{\underset{>}{\circ}} B = p_{13}(A \overset{a}{\underset{>}{\times}} B)$ where $A \overset{a}{\underset{>}{\times}} B = p_{12^a}^{-1}(A) \cap p_{23}^{-1}(B)$.

Definition 2.2.1. Let Λ be a closed conic subset of T^*M . We set

$$\mathcal{HH}(\mathbf{k}_M) := \delta^{-1}\mu hom(\omega_{\Delta_M}^{\otimes -1}, \mathbf{k}_{\Delta_M}),$$

$$\mathbb{HH}^0_{\Lambda}(\mathbf{k}_M) := H^0(T^*M; \mathcal{HH}_{\Lambda}(\mathbf{k}_M)).$$

We call $\mathcal{HH}(\mathbf{k}_M)$ the microlocal Hochschild homology of M.

We have isomorphisms

$$\mathcal{HH}(\mathbf{k}_M) \simeq \delta^{-1}\mu hom(\mathbf{k}_{\Delta},\omega_{\Delta}) \simeq \delta^{-1}\mu_{\Delta}(\omega_{\Delta}) \simeq \pi_M^{-1}\omega_M$$

and the isomorphism $\mathscr{HH}(\mathbf{k}_M) \simeq \pi_M^{-1} \omega_M$ plays the role of the HKR isomorphism in the complex case.

We have the analogue of Theorem 2.1.1 (a) and (b). (For the part (c), see Theorem 2.3.1 below.)

Let $i=1,2,\ j=i+1$ and let Λ_{ij} be a closed conic subset of T^*M_{ij} . Assume that

(2.2.3)
$$\Lambda_{12} \overset{a}{\underset{2}{\times}} \Lambda_{23} \text{ is proper over } T^*M_{13}.$$

Note that this hypothesis is equivalent to

$$\begin{cases} p_{12^a}^{-1}(\Lambda_{12}) \cap p_{23^a}^{-1}(\Lambda_{23}) \cap (T_{M_1}^* M_1 \times T^* M_2 \times T_{M_3}^* M_3) \subset T_{M_{123}}^* M_{123}, \\ q_{13} \text{ is proper on } \pi_{12}(\Lambda_{12}) \times_{M_2} \pi_{23}(\Lambda_{23}). \end{cases}$$

Set

$$\Lambda_{13} = \Lambda_{12} \stackrel{a}{\circ} \Lambda_{23}.$$

Theorem 2.2.2. (a) There is a natural morphism

$$(2.2.5) \mathcal{HH}(\mathbf{k}_{M_{12}}) \circ \mathcal{HH}(\mathbf{k}_{M_{23}}) \to \mathcal{HH}(\mathbf{k}_{M_{13}}).$$

(b) Let $\Lambda_{ij} \subset T^*M_{ij}$ be as above and assume (2.2.3). Then morphism (2.2.5) induces a map

$$(2.2.6) \qquad \qquad \circ : \mathbb{HH}^0_{\Lambda_{12}}(\mathbf{k}_{M_{12}}) \otimes \mathbb{HH}^0_{\Lambda_{23}}(\mathbf{k}_{X_{23}}) \to \mathbb{HH}^0_{\Lambda_{13}}(\mathbf{k}_{X_{13}}).$$

The construction of the morphism (2.2.5) uses (2.2.2), which makes the computations not easy. Fortunately, we have the following result, a kind of HKR isomorphism for sheaves.

Proposition 2.2.3. Let M_i (i = 1, 2, 3) be manifolds and let Λ_{ij} be a closed conic subset of T^*M_{ij} (ij = 12, 13, 23). We have a commutative diagram

$$(2.2.7) \qquad \mathcal{HH}(\mathbf{k}_{12}) \overset{a}{\underset{2}{\circ}} \mathcal{HH}(\mathbf{k}_{23}) \longrightarrow \mathcal{HH}(\mathbf{k}_{13})$$

$$\downarrow \emptyset \qquad \qquad \downarrow \emptyset$$

$$\pi_{12}^{-1} \omega_{12} \overset{a}{\underset{2}{\circ}} \pi_{23}^{-1} \omega_{23} \longrightarrow \pi_{13}^{-1} \omega_{13}.$$

Here the bottom horizontal arrow is induced by

$$p_{12^{a}}^{-1}\pi_{12}^{-1}\omega_{12} \otimes p_{23^{a}}^{-1}\pi_{23^{a}}^{-1}\omega_{23} \simeq \pi_{1}^{-1}\omega_{1} \boxtimes \omega_{T^{*}M_{2}} \boxtimes \pi_{3}^{-1}\omega_{3}$$
 and
$$Rp_{13^{a}!}(\pi_{1}^{-1}\omega_{1} \boxtimes \omega_{T^{*}M_{2}} \boxtimes \pi_{M_{3}}^{-1}\omega_{3}) \longrightarrow \pi_{1}^{-1}\omega_{1} \boxtimes \pi_{3}^{-1}\omega_{3}.$$

Remark 2.2.4. (i) If we consider that the isomorphism $\mathcal{HH}(\mathbf{k}_M) \simeq \pi^{-1}\omega_M$ is a real analogue of the Hochschild-Kostant-Rosenberg isomorphism, then the commutativity of Diagram (2.2.7) says that, contrarily to the complex case, the real HKR isomorphism commutes with inverse and direct images.

(ii) As a particular case of Proposition 2.2.3, we get canonical isomorphisms

$$\mathscr{HH}(\mathbf{k}_M)\otimes \mathscr{HH}(\mathbf{k}_M)\simeq \pi^{-1}\omega_M\otimes \pi^{-1}\omega_M\simeq \omega_{T^*M}.$$

Hence, $\mathcal{HH}(\mathbf{k}_M)$ behaves as a "square root" of the dualizing complex.

2.3 Hochschild kernels and microlocal Euler classes

A Hochschild kernel (K, u, v) on M is the data of $K \in \mathsf{D}^{\mathsf{b}}(\mathbf{k}_{M \times M})$ together with morphisms (u, v)

$$\omega_{\Delta}^{\otimes -1} \xrightarrow{u} K \xrightarrow{v} \mathbf{k}_{\Delta}.$$

Setting $SS_{\Delta}(K) := SS(K) \cap T_{\Delta}^*(M \times M)$, the morphism u gives an element of $H^0_{SS_{\Delta}(K)}(T^*M; \mu hom(\omega_{\Delta}^{\otimes -1}, K))$ whose image by v is the microlocal Euler class of K

$$\mu \mathrm{eu}_M(K) \in \mathbb{HH}^0_{\mathrm{SS}_{\Delta}(K)}(\mathbf{k}_M)) \simeq H^0_{\mathrm{SS}_{\Delta}(K)}(T^*M; \pi^{-1}\omega_M).$$

If $M=\operatorname{pt}$, a Hochschild kernel K is nothing but an object of $\mathsf{D}^{\mathrm{b}}(\mathbf{k})$ together with linear maps $\mathbf{k}\to K\to \mathbf{k}$. The composition gives the element $\mu\mathrm{eu}(K)$ of \mathbf{k} . If \mathbf{k} is a field of characteristic zero and $K=L\otimes L^*$ where L is a bounded complex of \mathbf{k} -modules with finite dimensional cohomology and L^* is its dual, one recover the classical Euler-Poincaré index of L, that is, $\mu\mathrm{eu}(K)=\chi(L)$.

Theorem 2.3.1. Let K_{ij} be a Hochschild kernel on M_{ij} with $SS_{\Delta}(K_{ij}) \subset \Lambda_{ij}$ (ij = 12, 23). Assume (2.2.3) and recall notation (2.2.4). Set $\widetilde{K}_{12} = K_{12} \otimes q_{22}^{-1}(\mathbf{k}_2 \boxtimes \omega_2)$ and $K_{13} = \widetilde{K}_{12} \underset{22}{\circ} K_{23}$. Then K_{13} is a Hochschild kernel on M_{13} and $\mu eu_{M_{13}}(K_{13}) = \mu eu_{M_{12}}(K_{12}) \underset{2}{\circ} \mu eu_{M_{23}}(K_{23})$ as elements of $\mathbb{HH}^0_{\Lambda_{13}}(\mathbf{k}_{13})$.

As an application, one can perform the external product, the proper direct image and the non characteristic inverse image of Hochschild kernels and compute their microlocal Euler classes.

Consider in particular the case where Λ_1 and Λ_2 are two closed conic subsets of T^*M satisfying the transversality condition

$$(2.3.1) \Lambda_1 \cap \Lambda_2^a \subset T_M^* M.$$

Then applying Theorem 2.3.1 and composing the external product with the restriction to the diagonal, we get a convolution map:

$$\star \colon \mathbb{HH}_{\Lambda_1}(\mathbf{k}_M) \times \mathbb{HH}_{\Lambda_2}(\mathbf{k}_M) \to \mathbb{HH}_{\Lambda_1+\Lambda_2}(\mathbf{k}_M).$$

Proposition 2.3.2. Let K_i be a Hochschild kernels with $SS_{\Delta}(K_i) \subset \Lambda_i$ (i = 1,2) and assume (2.3.1). Then the object $K_1 \otimes K_2$ is a Hochschild kernel on M and

$$\mu \operatorname{eu}_M(K_1 \otimes K_2) = \mu \operatorname{eu}_M(K_1) \star \mu \operatorname{eu}_M(K_2).$$

In particular if supp $K_1 \cap \text{supp } K_2$ is compact, we have

$$\mu \mathrm{eu}(\mathrm{R}\Gamma(X \times X; K_1 \otimes K_2)) = \int_M (\mu \mathrm{eu}(K_1) \star \mu \mathrm{eu}(K_2))|_M$$
$$= \int_{T^*M} \mu \mathrm{eu}(K_1) \cup \mu \mathrm{eu}(K_2).$$

We shall apply this result to elliptic pairs.

2.4 Microlocal Euler class of constructible sheaves

Let us denote by $\mathsf{D}^{\mathsf{b}}_{\mathsf{cc}}(\mathbf{k}_M)$ the full triangulated subcategory of $\mathsf{D}^{\mathsf{b}}(\mathbf{k}_M)$ consisting of cohomologically constructible sheaves and let $G \in \mathsf{D}^{\mathsf{b}}_{\mathsf{cc}}(\mathbf{k}_M)$.

The evaluation morphism $G \overset{\mathrm{L}}{\otimes} \mathrm{D}'G \to \mathbf{k}_M$ gives by adjunction the morphism $G \overset{\mathrm{L}}{\boxtimes} \mathrm{D}'G \to \mathbf{k}_\Delta$. By duality, one gets the morphism $\omega_\Delta^{\otimes -1} \to G \overset{\mathrm{L}}{\boxtimes} \mathrm{D}'G$. To summarize, we have the morphisms in $\mathsf{D}^{\mathrm{b}}_{\mathrm{cc}}(\mathbf{k}_{M \times M})$:

(2.4.1)
$$\omega_{\Delta}^{\otimes -1} \to G \stackrel{\mathcal{L}}{\boxtimes} \mathcal{D}' G \to \mathbf{k}_{\Delta}.$$

Denote by $\mathrm{HK}(G)$ the Hochschild kernel so constructed. If G is \mathbb{R} -constructible, the class $\mu\mathrm{eu}_M(\mathrm{HK}(G))$ is nothing but the Lagrangian cycle of G constructed by Kashiwara [Ka85]. In the sequel, if there is no risk of confusion, we simply denote this class by $\mu\mathrm{eu}_M(G)$.

2.5 Microlocal Euler class of \mathcal{D} -modules

In this section, we denote by X a complex manifold of complex dimension d_X and the base ring \mathbf{k} is the field \mathbb{C} . One denotes by \mathscr{D}_X the sheaf of \mathbb{C}_{X^-} algebras of (finite order) holomorphic differential operators on X and refer to [Ka03] for a detailed exposition of the theory of \mathscr{D} -modules.

We also denote by $\mathsf{D}^{\mathrm{b}}_{\mathrm{coh}}(\mathscr{D}_X)$ the full triangulated subcategory of $\mathsf{D}^{\mathrm{b}}(\mathscr{D}_X)$ consisting of objects with coherent cohomology.

We denote by $\mathsf{D}'_D \colon \mathsf{D}^{\mathrm{b}}(\mathscr{D}_X) \to \mathsf{D}^{\mathrm{b}}(\mathscr{D}_X)$ the duality functor for left \mathscr{D} -modules:

$$\mathrm{D}'_D\mathscr{M}:=\mathrm{R}\mathscr{H}om_{\mathscr{D}_X}(\mathscr{M},\mathscr{D}_X)\otimes_{\mathscr{O}_X}\Omega_X^{\otimes -1}.$$

We denote by $\bullet \, \underline{\boxtimes} \, \bullet \,$ the external product for $\mathcal D\text{-modules:}$

$$\mathscr{M}\underline{\boxtimes}\mathscr{N}:=\mathscr{D}_{X\times X}\otimes_{\mathscr{D}_X\boxtimes\mathscr{D}_X}(\mathscr{M}\boxtimes\mathscr{N}).$$

2.5. \mathscr{D} -MODULES 25

Let Δ be the diagonal of $X \times X$. The left $\mathscr{D}_{X \times X}$ -module $H^{d_X}_{[\Delta]}(\mathscr{O}_{X \times X})$ (the algebraic cohomology with support in Δ) is denoted as usual by \mathscr{B}_{Δ} . We also introduce $\mathscr{B}_{\Delta}^{\otimes -1} := \mathrm{D}'_D \mathscr{B}_{\Delta}$. For a coherent \mathscr{D}_X -module \mathscr{M} , we have the isomorphism

$$R\mathscr{H}om_{\mathscr{D}_X}(\mathscr{M},\mathscr{M}) \ \simeq \ R\mathscr{H}om_{\mathscr{D}_{X\times X}}(\mathscr{B}_{\Delta}^{\otimes -1},\mathscr{M}\underline{\boxtimes} D_D'\mathscr{M}).$$

We get the morphisms

$$\mathscr{B}_{\Delta}^{\otimes -1} \to \mathscr{M} \boxtimes \mathcal{D}_{D}' \mathscr{M} \to \mathscr{B}_{\Delta}$$

where the second morphism is deduced by duality.

Denote by \mathscr{E}_{T^*X} the sheaf on T^*X of microdifferential operators of [SKK73]. For a coherent \mathscr{D}_X -module \mathscr{M} set

$$\mathscr{M}^E := \mathscr{E}_{T^*X} \otimes_{\pi^{-1}\mathscr{D}_X} \pi^{-1}\mathscr{M}.$$

Recall that, denoting by $\operatorname{char}(\mathcal{M})$ the characteristic variety of \mathcal{M} , we have $\operatorname{char}(\mathcal{M}) = \operatorname{supp}(\mathcal{M}^E)$. Set

$$\mathscr{C}_{\Delta} := \mathscr{B}_{\Delta}^{E}, \quad \mathscr{C}_{\Delta}^{\otimes -1} := (\mathscr{B}_{\Delta}^{\otimes -1})^{E}.$$

Let Λ be a closed conic subset of T^*X . One sets

$$\mathcal{HH}(\mathscr{E}_{T^*X}) = \delta^{-1} R \mathscr{H}om_{\mathscr{E}_{X\times X}}(\mathscr{C}_{\Delta}^{\otimes -1}, \mathscr{C}_{\Delta}),$$

$$\mathbb{HH}^0_{\Lambda}(\mathscr{E}_{T^*X}) = H^0_{\Lambda}(T^*X; \mathcal{HH}(\mathscr{E}_{T^*X})).$$

We deduce from (2.5.1) the morphisms

$$(2.5.2) \mathscr{C}_{\Delta}^{\otimes -1} \to (\mathscr{M} \boxtimes D_D' \mathscr{M})^E \to \mathscr{C}_{\Delta}$$

which define the Hochschild class of \mathcal{M} :

(2.5.3)
$$\mathrm{hh}_{\mathscr{E}}(\mathscr{M}) \in \mathbb{HH}^{0}_{\mathrm{char}(\mathscr{M})}(\mathscr{E}_{T^{*}X}).$$

We shall make a link between the Hochschild class of \mathcal{M} and the microlocal Euler class of a Hochschild kernel attached to the sheaves of holomorphic solutions of \mathcal{M} . We have

$$\Omega_{X\times X}[-d_X] \overset{\mathbf{L}}{\otimes}_{\mathscr{D}_{X\times X}} \mathscr{B}_{\Delta}^{\otimes -1} \simeq \mathbf{R}\mathscr{H}om_{\mathscr{D}_{X\times X}} (\mathscr{B}_{\Delta}, \mathscr{O}_{X\times X})[-d_X] \simeq \omega_{\Delta}^{\otimes -1},$$

$$\Omega_{X\times X} \overset{\mathbf{L}}{\otimes}_{\mathscr{D}_{X\times X}} \mathscr{B}_{\Delta}[-d_X] \simeq \mathbb{C}_{\Delta}.$$

Now remark that for $\mathcal{N}_1, \mathcal{N}_2 \in \mathsf{D}^{\mathsf{b}}_{\mathsf{coh}}(\mathcal{D}_X)$, we have a natural morphism

$$R\mathscr{H}om_{\pi^{-1}\mathscr{D}_X}(\pi^{-1}\mathscr{N}_1,\mathscr{N}_2^E) \to \mu hom(\Omega_X \overset{L}{\otimes}_{\mathscr{D}_X} \mathscr{N}_1, \Omega_X \overset{L}{\otimes}_{\mathscr{D}_X} \mathscr{N}_2).$$

One deduces the morphisms

$$\begin{split} \mathbf{R}\mathscr{H}\!\mathit{om}_{\mathscr{E}_{X\times X}}(\mathscr{C}_{\Delta}^{\otimes -1},\mathscr{C}_{\Delta}) & \simeq \mathbf{R}\mathscr{H}\!\mathit{om}_{\pi^{-1}\mathscr{D}_{X\times X}}(\pi^{-1}\mathscr{B}_{\Delta}^{\otimes -1},\mathscr{B}_{\Delta}^{E}) \\ & \to \mu hom(\Omega_{X\times X} \overset{\mathbf{L}}{\otimes_{\mathscr{D}_{X\times X}}} \mathscr{B}_{\Delta}^{\otimes -1}, \Omega_{X\times X} \overset{\mathbf{L}}{\otimes_{\mathscr{D}_{X\times X}}} \mathscr{B}_{\Delta}) \\ & \simeq \mu hom(\omega_{\Delta}^{\otimes -1}, \mathbb{C}_{\Delta}). \end{split}$$

Since all the arrows above are isomorphisms, we get

$$\mathcal{HH}(\mathscr{E}_{T^*X}) \simeq \mathcal{HH}(\mathbb{C}_X).$$

Recall that the Hochschild homology of \mathcal{E}_{T^*X} has been already calculated in [BG87].

By this isomorphism, $\mathrm{hh}_{\mathscr{E}}(\mathscr{M})$ belongs to $\mathbb{HH}^0_{\mathrm{char}(\mathscr{M})}(\mathbb{C}_X)$ and this class coincides with that already introduced in [ScSn94].

Applying the functor $\Omega_{X\times X}[-d_X] \overset{\text{L}}{\otimes}_{\mathscr{D}_{X\times X}}$ • to the morphisms in (2.5.1) we get the morphisms

$$(2.5.4) \qquad \omega_{\Delta}^{\otimes -1} \to \Omega_{X \times X}[-d_X] \overset{\mathbf{L}}{\otimes}_{\mathscr{D}_{X \times X}}(\mathscr{M} \underline{\boxtimes} \mathrm{D}'_D \mathscr{M}) \to \mathbb{C}_{\Delta}.$$

For $\mathscr{M} \in \mathsf{D}^{\mathsf{b}}_{\mathsf{coh}}(\mathscr{D}_X)$, we denote by $\mathsf{HK}(\mathscr{M})$ the Hochschild kernel given by (2.5.4). Since $\mathsf{char}(\mathscr{M}) = \mathsf{SS}(\mathsf{R}\mathscr{H}\mathit{om}_{\mathscr{D}_X}(\mathscr{M},\mathscr{O}_X))$ by Theorem 1.3.4, we get $\mathsf{that}\ \mu\mathsf{eu}_M(\mathsf{HK}(\mathscr{M}))$ is supported by $\mathsf{char}(\mathscr{M})$, the characteristic variety of \mathscr{M} .

Proposition 2.5.1. We have $\mathrm{hh}_{\mathscr{E}}(\mathscr{M}) = \mu \mathrm{eu}_X(\mathrm{HK}(\mathscr{M}))$ in $\mathbb{HH}^0_{\mathrm{char}(\mathscr{M})}(\mathbb{C}_X)$.

2.6 Microlocal Euler class of elliptic pairs

Let X be a complex manifold, \mathscr{M} an object of $\mathsf{D}^{\mathsf{b}}_{\mathsf{coh}}(\mathscr{D}_X)$ and G an object of $\mathsf{D}^{\mathsf{b}}_{\mathbb{R}-\mathsf{c}}(\mathbb{C}_X)$. Recall that we have denoted by $\mathsf{HK}(G)$ and $\mathsf{HK}(\mathscr{M})$ the Hochschild kernels associated with G and with \mathscr{M} , respectively:

$$\begin{aligned} \mathrm{HK}(G) &= G \boxtimes \mathrm{D}'G, \\ \mathrm{HK}(\mathscr{M}) &= \Omega_{X \times X} \left[-d_X \right] \overset{\mathrm{L}}{\otimes}_{\mathscr{D}_{X \times Y}} (\mathscr{M} \underline{\boxtimes} \mathrm{D}'_D \mathscr{M}). \end{aligned}$$

The pair (\mathcal{M}, G) is called an elliptic pair in $[\operatorname{ScSn94}]$ if $\operatorname{char}(\mathcal{M}) \cap \operatorname{SS}(G) \subset T_X^*X$. From now on, we assume that (\mathcal{M}, G) is an elliptic pair. This implies that the tensor product of the Hochschild kernels $\operatorname{HK}(\mathcal{M})$ and $\operatorname{HK}(G)$ is again a Hochschild kernel, and denoting it by $\operatorname{HK}(\mathcal{M}, G)$, we have:

(2.6.1)
$$\operatorname{HK}(\mathcal{M}, G) \simeq \Omega_{X \times X} [-d_X] \overset{\operatorname{L}}{\otimes}_{\mathscr{D}_{X \times X}} ((\mathcal{M} \otimes F) \underline{\boxtimes} (\operatorname{D}'_D \mathcal{M} \otimes \operatorname{D}' F)),$$

(2.6.2) $\mu \operatorname{eu}_Y (\operatorname{HK}(\mathcal{M}, G)) = \mu \operatorname{eu}_Y (\mathcal{M}) \star \mu \operatorname{eu}_Y (G).$

Applying Corollary 1.5.2 (a), we get the natural isomorphism

$$(2.6.3) R\mathscr{H}om_{\mathscr{D}_{X}}(\mathscr{M}, \mathsf{D}'G\otimes\mathscr{O}_{X}) \xrightarrow{\sim} R\mathscr{H}om_{\mathscr{D}_{X}}(\mathscr{M}\otimes G, \mathscr{O}_{X}).$$

Assume moreover that $\operatorname{Supp}(\mathcal{M}) \cap \operatorname{Supp}(G)$ is compact. Applying Corollary 1.5.2 (b), we get that the cohomology of the complex

$$\operatorname{Sol}(\mathscr{M} \otimes G) := \operatorname{RHom}_{\mathscr{D}_{\mathbf{Y}}}(\mathscr{M} \otimes G, \mathscr{O}_{X})$$

is finite dimensional. Moreover

$$R\Gamma(X \times X; HK(\mathcal{M}, G)) \simeq Sol(\mathcal{M} \otimes G) \otimes Sol(\mathcal{M} \otimes G)^*.$$

Applying Proposition 2.3.2, we get

$$\chi(\operatorname{R}\mathscr{H}om_{\mathscr{D}_X}(\mathscr{M}\otimes G,\mathscr{O}_X)) = \int_X (\operatorname{hh}_{\mathscr{E}}(\mathscr{M}) \star \mu \operatorname{eu}_X(G))|_X$$
$$= \int_{T^*X} (\operatorname{hh}_{\mathscr{E}}(\mathscr{M}) \cup \mu \operatorname{eu}_X(G)).$$

This formula has many applications, as far as one is able to calculate $\mu eu_X(\mathcal{M})$. In [ScSn94] we made the conjecture that

$$\mathrm{hh}_{\mathscr{E}}(\mathscr{M}) = [\mathrm{Ch}(\mathrm{gr}(\mathscr{M})) \cup \mathrm{Td}_X]^{d_X}$$

where \mathcal{M} being endowed with a good filtration, $gr(\mathcal{M})$ is the associated graded module, an $\mathcal{O}_{T^*X^-}$ module, Ch is the Chern character and Td is the Todd class. This conjecture has been proved in [BNT02] by Bressler-Nest-Tsygan and generalized in [1].

For example, if M is a compact real analytic manifold and X is a complexification of M, one recovers the Atiyah-Singer theorem by choosing $G = D'\mathbb{C}_M$. If X is a complex compact manifold, one recovers the Riemann-Roch theorem: one takes $G = \mathbb{C}_X$ and if \mathscr{F} is a coherent \mathscr{O}_X -module, one sets $\mathscr{M} = \mathscr{D}_X \otimes_{\mathscr{O}_X} \mathscr{F}$.

Lecture 3

Ind-sheaves and applications to \mathcal{D} -modules

Abstract. I will first recall the constructions of [KS96, KS01] of the sheaves of temperate or Whitney holomorphic functions. These are not sheaves on the usual topology, but sheaves on the subanalytic site or better, ind-sheaves. Then I will explain how these objects appear naturally in the study of irregular holonomic \mathcal{D} -modules.

3.1 Ind-sheaves

Ind-objects

References are made to [SGA4] or to [KS06] for an exposition. We keep the notations of the preceding lectures.

Let \mathscr{C} be an abelian category (in a given universe \mathscr{U}). One denotes by $\mathscr{C}^{\wedge,add}$ the big category of additive functors from \mathscr{C}^{op} to $\text{Mod}(\mathbb{Z})$. This big category is abelian and the functor $h^{\wedge} \colon \mathscr{C} \to \mathscr{C}^{\wedge}$ makes \mathscr{C} a full abelian subcategory of $\mathscr{C}^{\wedge,add}$. This functor is left exact, but not exact in general.

An ind-object in $\mathscr C$ is an object $A\in\mathscr C^\wedge$ which is isomorphic to " \varinjlim " α

for some functor $\alpha \colon I \to \mathscr{C}$ with I filtrant and small. One denotes by $\operatorname{Ind}(\mathscr{C})$ the full additive subcategory of $\mathscr{C}^{\wedge,add}$ consisting of ind-objects.

Theorem 3.1.1. (i) The category $\operatorname{Ind}(\mathscr{C})$ is abelian.

- (ii) The natural functor $\mathscr{C} \to \operatorname{Ind}(\mathscr{C})$ is fully faithful and exact and the natural functor $\operatorname{Ind}(\mathscr{C}) \to \mathscr{C}^{\wedge,add}$ is fully faithful and left exact.
- (iii) The category $\operatorname{Ind}(\mathscr{C})$ admits exact small filtrant inductive limits and the functor $\operatorname{Ind}(\mathscr{C}) \to \mathscr{C}^{\wedge,add}$ commutes with such limits.

(iv) Assume that \mathscr{C} admits small projective limits. Then the category $\operatorname{Ind}(\mathscr{C})$ admits small projective limits, and the functor $\mathscr{C} \to \operatorname{Ind}(\mathscr{C})$ commutes with such limits.

Example 3.1.2. Assume that \mathbf{k} is a field. Let $I(\mathbf{k})$ denote the category of ind-objects of $\operatorname{Mod}(\mathbf{k})$. Define $\beta \colon \operatorname{Mod}(\mathbf{k}) \to I(\mathbf{k})$ by setting $\beta(V) =$ " \varinjlim " W, where W ranges over the family of finite-dimensional vector subspaces of V. In other words, $\beta(V)$ is the functor form $\operatorname{Mod}(\mathbf{k})^{\operatorname{op}}$ to $\operatorname{Mod}(\mathbb{Z})$ given by $M \mapsto \varinjlim_{W} \operatorname{Hom}_{k}(M, W)$. Therefore,

$$\begin{array}{rcl} \varinjlim_{W\subset V,W\in\operatorname{Mod}^{\mathrm{f}}(\mathbf{k})}\operatorname{Hom}_{\mathbf{k}}(L,W) &\simeq & \operatorname{Hom}_{\mathrm{I}(\mathbf{k})}(L, \ \limsup_{W\subset V,W\in\operatorname{Mod}^{\mathrm{f}}(\mathbf{k})}W) \\ &= & \operatorname{Hom}_{\mathrm{I}(\mathbf{k})}(L,\beta(V)). \end{array}$$

If V is infinite-dimensional, $\beta(V)$ is not representable in $\operatorname{Mod}(\mathbf{k})$. Moreover, $\operatorname{Hom}_{\mathsf{I}(\mathbf{k})}(\mathbf{k},V/\beta(V)) \simeq 0$.

It is proved in [KS06] that the category $\operatorname{Ind}(\mathscr{C})$ for $\mathscr{C} = \operatorname{Mod}(\mathbf{k})$ does not have enough injectives.

Definition 3.1.3. An object $A \in \operatorname{Ind}(\mathscr{C})$ is quasi-injective if the functor $\operatorname{Hom}_{\operatorname{Ind}(\mathscr{C})}({\:}^{\bullet},A)$ is exact on the category \mathscr{C} .

It is proved in loc. cit. that if $\mathscr C$ has enough injectives, then $\mathrm{Ind}(\mathscr C)$ has enough quasi-injectives.

Ind-sheaves

References are made to [KS01].

Let X be a locally compact space countable at infinity. Recall that $\operatorname{Mod}(\mathbf{k}_X)$ denotes the abelian category of sheaves of \mathbf{k} -modules on X. We denote by $\operatorname{Mod^c}(\mathbf{k}_X)$ the full subcategory consisting of sheaves with compact support. We set for short:

$$I(\mathbf{k}_X) := Ind(Mod^c(\mathbf{k}_X))$$

and call an object of this category an indsheaf on X.

Theorem 3.1.4. The prestack $U \mapsto I(\mathbf{k}_U)$, U open in X is a stack.

The following example explains why we have considered sheaves with compact supports.

Example 3.1.5. Let $X = \mathbb{R}$, let $F = \mathbf{k}_X$, $G_n = \mathbf{k}_{[n,+\infty[}, G = \lim_{n \to \infty} G_n$.

Then $G|_U = 0$ in $\operatorname{Ind}(\operatorname{Mod}(\mathbf{k}_U))$ for any relatively compact open subset U of X. On the other hand, $\operatorname{Hom}_{\operatorname{Ind}(\operatorname{Mod}(\mathbf{k}_X))}(\mathbf{k}_X, G) \simeq \varinjlim_n \operatorname{Hom}_{\mathbf{k}_X}(\mathbf{k}_X, G_n) \simeq \mathbf{k}$.

We have two pairs (α_X, ι_X) and (β_X, α_X) of adjoint functors

$$\operatorname{Mod}(\mathbf{k}_X) \xrightarrow{\iota_X} \operatorname{I}(\mathbf{k}_X).$$

The functor ι_X is the natural one. If F has compact support, $\iota_X(F) = F$ after identifying a category $\mathscr C$ to a full subcategory of $\operatorname{Ind}(\mathscr C)$. The functor α_X associates $\varinjlim_i F_i$ ($F_i \in \operatorname{Mod^c}(\mathbf k_X)$, $i \in I$, I small and filtrant) to the object " $\varinjlim_i F_i$. If $\mathbf k$ is a field, $\beta_X(F)$ is the functor $G \mapsto \Gamma(X; H^0(D'G) \otimes F)$.

- ι_X is exact, fully faithful, and commutes with $\underline{\lim}$,
- α_X is exact and commutes with \varprojlim and \varinjlim ,
- β_X is right exact, fully faithful and commutes with \varinjlim ,
- α_X is left adjoint to ι_X ,
- α_X is right adjoint to β_X ,
- $\alpha_X \circ \iota_X \simeq \mathrm{id}_{\mathrm{Mod}(\mathbf{k}_X)}$ and $\alpha_X \circ \beta_X \simeq \mathrm{id}_{\mathrm{Mod}(\mathbf{k}_X)}$.

Example 3.1.6. Let $U \subset X$ be an open subset, $S \subset X$ a closed subset. Then

$$\beta_X(\mathbf{k}_U) \simeq \underset{\overline{V}}{\text{lim}}, \mathbf{k}_V, V \text{ open }, V \subset\subset U,$$

 $\beta_X(\mathbf{k}_S) \simeq \underset{\overline{V}}{\text{lim}}, \mathbf{k}_{\overline{V}}, V \text{ open }, S \subset V.$

Let $a \in X$ and consider the skyscraper sheaf $\mathbf{k}_{\{a\}}$. Then $\beta_X(\mathbf{k}_{\{a\}}) \to \mathbf{k}_{\{a\}}$ is an epimorphism in $I(\mathbf{k}_X)$ and defining N_a by the exact sequence:

$$0 \to N_a \to \beta_X(\mathbf{k}_{\{a\}}) \to \mathbf{k}_{\{a\}} \to 0$$

we get that $\operatorname{Hom}_{\mathrm{I}(\mathbf{k}_X)}(\mathbf{k}_U, N_a) \simeq 0$ for all open neighborhood U of a.

We shall not recall here the construction of the derived category of indsheaves, nor the six operations on such "sheaves".

3.2 Sheaves on the subanalytic site

The subanalytic site was introduced in [KS01, Chapt 7] and the results on sheaves on this site were obtained as particular cases of more general results on indsheaves, which makes the reading not so easy. A direct and more elementary study of sheaves on the subanalytic site is performed in [Pr08, Pr12].

Let M be a real analytic manifold. One denotes by $\mathbb{R}\text{-}\mathrm{C}(\mathbf{k}_M)$ the abelian category of \mathbb{R} -constructible sheaves on M and by $\mathbb{R}\text{-}\mathrm{C}^c(\mathbf{k}_M)$ the full subcategory consisting of sheaves with compact support. There is an equivalence $\mathsf{D}^{\mathrm{b}}(\mathbb{R}\text{-}\mathrm{C}(\mathbf{k}_M)) \simeq \mathsf{D}^{\mathrm{b}}_{\mathbb{R}\text{-c}}(\mathbf{k}_M)$ where this last category is the full triangulated subcategory of $\mathsf{D}^{\mathrm{b}}(\mathbf{k}_M)$ consisting of \mathbb{R} -constructible sheaves. (This classical result has first been proved by Kashiwara [Ka84].)

We denote by Op_M the category whose objects are the open subsets of M and the morphisms are the inclusions of open subsets. One defines a Grothendieck topology on Op_M by deciding that a family $\{U_i\}_{i\in I}$ of subobjects of $U \in \operatorname{Op}_M$ is a covering of U if it is a covering in the usual sense.

Definition 3.2.1. Denote by $\operatorname{Op}_{M_{\operatorname{sa}}}$ the full subcategory of Op_{M} consisting of subanalytic and relatively compact open subsets. The site M_{sa} is obtained by deciding that a family $\{U_i\}_{i\in I}$ of subobjects of $U\in\operatorname{Op}_{M_{\operatorname{sa}}}$ is a covering of U if there exists a finite subset $J\subset I$ such that $\bigcup_{i\in J}U_i=U$.

Let us denote by

$$(3.2.1) \rho: M \to M_{\rm sa}$$

the natural morphism of sites. Here again, we have two pairs of adjoint functors (ρ^{-1}, ρ_*) and $(\rho_!, \rho^{-1})$:

$$\operatorname{Mod}(\mathbf{k}_M) \xrightarrow{\rho_* \atop \longleftarrow \rho^{-1} \longrightarrow \atop \rho_!} \operatorname{I}(\mathbf{k}_M).$$

For $F \in \operatorname{Mod}(\mathbf{k}_M)$, $\rho_! F$ is the sheaf associated to the presheaf $U \mapsto F(\overline{U})$, $U \in \operatorname{Op}_{M_{\operatorname{sa}}}$.

Proposition 3.2.2. The restriction of the functor ρ_* to the category \mathbb{R} - $\mathbb{C}(\mathbf{k}_M)$ is exact and fully faithful.

By this result, we shall consider the category \mathbb{R} -C(\mathbf{k}_M) as well as a subcategory of $\mathrm{Mod}(\mathbf{k}_M)$ as of $\mathrm{Mod}(\mathbf{k}_{M_{\mathrm{sa}}})$. Set

$$I_{\mathbb{R}-c}(\mathbf{k}_M) = Ind(\mathbb{R}-C^c(\mathbf{k}_M)).$$

Theorem 3.2.3. The natural functor $\alpha_{M_{\mathrm{sa}}} \colon \mathrm{I}(\mathbf{k}_{M_{\mathrm{sa}}}) \to \mathrm{Mod}(\mathbf{k}_{M_{\mathrm{sa}}})$ induces an equivalence

$$I_{\mathbb{R}-c}(\mathbf{k}_M) \simeq \operatorname{Mod}(\mathbf{k}_{M_{\operatorname{sa}}}).$$

In other words, ind- \mathbb{R} -constructible sheaves are "usual sheaves" on the subanalytic site. By this result, the embedding \mathbb{R} - $C^c(\mathbf{k}_M) \hookrightarrow \operatorname{Mod}^c(\mathbf{k}_M)$ gives a functor $I_M \colon \operatorname{Mod}(\mathbf{k}_{M_{\operatorname{sa}}}) \to \operatorname{I}(\mathbf{k}_M)$. Hence, we have a quasi-commutative diagram of categories

(3.2.2)
$$\operatorname{Mod}(\mathbf{k}_{M}) \xrightarrow{\iota_{M}} \operatorname{I}(\mathbf{k}_{M})$$

$$\uparrow \qquad \qquad \uparrow_{I_{M}}$$

$$\operatorname{Mod}_{\mathbb{R}\text{-c}}(\mathbf{k}_{M}) \xrightarrow{\rho_{*}} \operatorname{Mod}(\mathbf{k}_{M_{\operatorname{sa}}})$$

in which all arrows are exact and fully faithful. One shall be aware that the diagram:

(3.2.3)
$$\operatorname{Mod}(\mathbf{k}_{M}) \xrightarrow{\iota_{M}} \operatorname{I}(\mathbf{k}_{M})$$

$$\stackrel{NC}{\underset{\rho_{*}}{\longrightarrow}} \operatorname{Mod}(\mathbf{k}_{M_{s_{n}}})$$

is not commutative. Moreover, ι_M is exact and ρ_* is not right exact in general. One denotes by " \varinjlim " the inductive limit in the category $\operatorname{Mod}(\mathbf{k}_{M_{\operatorname{sa}}})$. One shall be aware that the functor I_M commutes with inductive limits but ρ_* does not.

3.3 Moderate and formal cohomology

From now on, $\mathbf{k} = \mathbb{C}$. As usual, we denote by \mathscr{C}_M^{∞} (resp. \mathscr{C}_M^{ω}) the sheaf of complex functions of class C^{∞} (resp. real analytic), by $\mathscr{D}b_M$ (resp. \mathscr{B}_M) the sheaf of Schwartz's distributions (resp. Sato's hyperfunctions), and by \mathscr{D}_M the sheaf of analytic finite-order differential operators. We also use the notation $\mathscr{A}_M = \mathscr{C}_M^{\omega}$.

Definition 3.3.1. Let $f \in \mathscr{C}_M^{\infty}(U)$. One says that f has polynomial growth at $p \in M$ if it satisfies the following condition. For a local coordinate system (x_1, \ldots, x_n) around p, there exist a sufficiently small compact neighborhood K of p and a positive integer N such that

$$(3.3.1) \sup_{x \in K \cap U} \left(\operatorname{dist}(x, K \setminus U) \right)^{N} |f(x)| < \infty.$$

It is obvious that f has polynomial growth at any point of U. We say that f is temperate at p if all its derivatives have polynomial growth at p. We say that f is temperate if it is temperate at any point.

For an open subanalytic set U in M, denote by $\mathscr{C}_M^{\infty,t}(U)$ the subspace of $\mathscr{C}_M^{\infty}(U)$ consisting of tempered functions.

Denote by $\mathcal{D}b_M^t(U)$ the space of tempered distributions on U, defined by the exact sequence

$$0 \to \Gamma_{M \setminus U}(M; \mathcal{D}b_M) \to \Gamma(M; \mathscr{D}b_M) \to \mathcal{D}b_M^t(U) \to 0.$$

Using Lojasiewicz's inequalities [Lo61] (see also [Ma67]), one easily proves that

- the presheaf $U \mapsto \mathscr{C}_{M}^{\infty,t}(U)$ is a sheaf on M_{sa} ,
- the presheaf $U \mapsto \mathcal{D}b_M^t(U)$ is a sheaf on M_{sa} .

One denotes by $\mathscr{C}^{\infty,t}_{M_{\operatorname{sa}}}$ the first one and calls it the sheaf of temperate C^{∞} functions. One denotes by $\mathcal{D}b^t_{M_{\operatorname{sa}}}$ the second one and calls it the sheaf of
temperate distributions. Let $F \in \mathsf{D}^{\mathsf{b}}_{\mathbb{R}-\mathsf{c}}(\mathbb{C}_M)$. One has the isomorphism

(3.3.2)
$$\rho^{-1} \mathcal{R} \mathcal{H} om(F, \mathcal{D} b_{M_{sa}}^{t}) \simeq thom(F, \mathcal{D} b_{M})$$

where the right-hand side was defined by Kashiwara as the main tool for his proof of the Riemann-Hilbert correspondence in [Ka80, Ka84].

For a closed subanalytic subset S in M, denote by $\mathscr{I}_{M,S}^{\infty}$ the subsheaf of \mathscr{C}_{M}^{∞} consisting of functions which vanish up to infinite order on S. In [KS96], one introduces the sheaf:

$$\mathbb{C}_U \overset{\mathrm{w}}{\otimes} \mathscr{C}_M^{\infty} := V \mapsto \Gamma(V; \mathscr{I}_{V,V \setminus U}^{\infty})$$

and shows how to extend this construction and define an exact functor $\bullet \overset{\text{w}}{\otimes} \mathscr{C}_M^{\infty}$ on $\operatorname{Mod}_{\mathbb{R}\text{-c}}(\mathbb{C}_M)$. One denotes by $\mathscr{C}_M^{\infty, \text{w}}$ the sheaf on M_{sa} given by

$$\mathscr{C}_{M}^{\infty,\mathrm{w}}(U) = \Gamma(M; H^{0}(\mathcal{D}'_{M}\mathbf{k}_{U}) \overset{\mathrm{w}}{\otimes} \mathscr{C}_{M}^{\infty}), U \in \mathrm{Op}_{M_{\mathrm{ss}}}.$$

If $\mathrm{D}'_M\mathbb{C}_U\simeq\mathbb{C}_{\overline{U}},\,\mathscr{C}^{\infty,\mathrm{w}}_M(U)$ is the space of Whitney functions on U, that is the quotient $\mathscr{C}^\infty(M)/\mathscr{I}^\infty_{M,M\setminus U}$. It is thus natural to call $\mathscr{C}^{\infty,\mathrm{w}}_M$ the sheaf of Whitney C^∞ -functions on M_{sa} .

Note that the sheaf $\rho_* \mathscr{D}_M$ does not operate on the sheaves $\mathscr{C}_M^{\infty,t}$, $\mathscr{D}b_M^t$, $\mathbb{C}_M^{\infty,w}$ but $\rho_! \mathscr{D}_M$ does.

Now let X be a *complex* manifold. We still denote by X the real underlying manifold and we denote by \overline{X} the complex manifold conjugate to X. One defines the sheaf of temperate holomorphic functions $\mathcal{O}_{X_{\operatorname{sa}}}^{\operatorname{t}}$ as the Dolbeault complex with coefficients in $\mathscr{C}_{X_{\operatorname{sa}}}^{\infty,t}$. More precisely

$$(3.3.3) \mathcal{O}_{X_{\text{sa}}}^{\text{t}} = R \mathscr{H}om_{\rho_! \mathscr{D}_{\overline{X}}}(\rho_! \mathscr{O}_{\overline{X}}, \mathscr{C}_{X_{\text{sa}}}^{\infty, t}).$$

One proves the isomorphism

$$(3.3.4) \mathcal{O}_{X_{\mathrm{sa}}}^{\mathrm{t}} \simeq \mathrm{R} \mathscr{H} om_{\rho_! \mathscr{D}_{\overline{X}}}(\rho_! \mathscr{O}_{\overline{X}}, \mathcal{D} b_{X_{\mathrm{sa}}}^t).$$

Similarly, one defines the sheaf

(3.3.5)
$$\mathcal{O}_{X_{\operatorname{sa}}}^{\operatorname{w}} = \operatorname{R}\mathscr{H}om_{\rho_{!}\mathscr{D}_{\overline{X}}}(\rho_{!}\mathscr{O}_{\overline{X}}, \mathscr{C}_{X_{\operatorname{sa}}}^{\infty,\operatorname{w}}).$$

Note that the objects $\mathcal{O}_{X_{\operatorname{sa}}}^{\operatorname{t}}$ and $\mathcal{O}_{X_{\operatorname{sa}}}^{\operatorname{w}}$ are not concentrated in degree zero in dimension > 1. Indeed, with the subanalytic topology, only finite coverings are allowed. If one considers for example the open set $U \subset \mathbb{C}^n$, the difference of a open ball of radius R > 0 and a closed ball of radius 0 < r < R, then the Dolbeault complex will not be exact after any finite covering. For the same reason, the sheaf $R\rho_*\mathcal{O}_X$ is not concentrated in degree zero in dimension > 1.

Therefore, we shall better consider indsheaves and we shall embed the category $\mathsf{D}^{\mathsf{b}}(\mathbb{C}_{X_{\mathrm{sa}}})$ into the category $\mathsf{D}^{\mathsf{b}}(\mathsf{I}(\mathbb{C}_X))$ by the exact functor I_X . Hence we consider subanalytic sheaves as indsheaves. In the category $\mathsf{D}^{\mathsf{b}}(\mathsf{I}(\mathbb{C}_X))$ we have thus the morphisms of sheaves

$$\mathcal{O}_X^{\omega} \to \mathcal{O}_X^{\mathrm{w}} \to \mathcal{O}_X^{\mathrm{t}} \to \mathscr{O}_X.$$

Here $\mathcal{O}_X^{\mathrm{w}}$ and $\mathcal{O}_X^{\mathrm{t}}$ are the images of $\mathcal{O}_{X_{\mathrm{sa}}}^{\mathrm{w}}$ and $\mathcal{O}_{X_{\mathrm{sa}}}^{\mathrm{t}}$ by the functor I_X (there are still not concentrated in degree 0), we have kept the same notation for \mathscr{O}_X and its image in $\mathrm{Mod}(\mathrm{I}(\mathbb{C}_X))$ by the functor ι_X , and we have set

$$\mathcal{O}_X^{\omega} := \beta_X(\mathscr{O}_X).$$

We call \mathcal{O}_X^{w} and \mathcal{O}_X^{t} the sheaves of temperate and Whitney holomorphic functions, respectively.

Example 3.3.2. Let Z be a closed complex analytic subset of the complex manifold X. We have the isomorphisms

$$\begin{split} &\alpha_X \mathrm{R}\mathscr{H}om_{\mathrm{I}(\mathbb{C}_X)}(\mathrm{D}'\mathbb{C}_Z,\mathcal{O}_X^\omega) \simeq \mathscr{O}_X|_Z,\\ &\alpha_X \mathrm{R}\mathscr{H}om_{\mathrm{I}(\mathbb{C}_X)}(\mathrm{D}'\mathbb{C}_Z,\mathcal{O}_X^\mathrm{w}) \simeq \mathscr{O}_X \widehat{|}_Z \text{ (formal completion along } Z),\\ &\alpha_X \mathrm{R}\mathscr{H}om_{\mathrm{I}(\mathbb{C}_X)}(\mathbb{C}_Z,\mathcal{O}_X^\mathrm{t}) \simeq \mathrm{R}\Gamma_{[Z]}(\mathscr{O}_X) \text{ (algebraic cohomology)},\\ &\alpha_X \mathrm{R}\mathscr{H}om_{\mathrm{I}(\mathbb{C}_X)}(\mathbb{C}_Z,\mathscr{O}_X) \simeq \mathrm{R}\Gamma_Z(\mathscr{O}_X). \end{split}$$

Example 3.3.3. let M be a real analytic manifold and X a complexification of M. We have the isomorphisms

$$\begin{split} &\alpha_X \mathrm{R}\mathscr{H}om_{\mathrm{I}(\mathbb{C}_X)}(\mathrm{D}'\mathbb{C}_M,\mathcal{O}_X^\omega) \simeq \mathscr{A}_M,\\ &\alpha_X \mathrm{R}\mathscr{H}om_{\mathrm{I}(\mathbb{C}_X)}(\mathrm{D}'\mathbb{C}_M,\mathcal{O}_X^\mathrm{w}) \simeq \mathscr{C}_M^\infty,\\ &\alpha_X \mathrm{R}\mathscr{H}om_{\mathrm{I}(\mathbb{C}_X)}(\mathrm{D}'\mathbb{C}_M,\mathcal{O}_X^\mathrm{t}) \simeq \mathcal{D}b_M,\\ &\alpha_X \mathrm{R}\mathscr{H}om_{\mathrm{I}(\mathbb{C}_X)}(\mathrm{D}'\mathbb{C}_M,\mathcal{O}_X) \simeq \mathscr{B}_M. \end{split}$$

Notice that with this approach, the sheaf $\mathcal{D}b_M$ of Schwartz's distributions is constructed similarly as the sheaf of Sato's hyperfunctions. In particular, functional analysis is not used in the construction.

3.4 Applications to \mathcal{D} -modules I

Let us show on an example extracted of [KS03] the possible role of the sheaf \mathcal{O}_X^t in the study of irregular holonomic \mathcal{D} -modules.

Let X be a complex manifold and let \mathscr{M} be a holonomic \mathscr{D} -module. We set for short

$$\mathcal{S}ol(\mathcal{M}) = \mathcal{H}om_{\mathscr{D}_X}(\mathcal{M}, \mathscr{O}_X),$$

 $\mathcal{S}ol^t(\mathcal{M}) = \mathcal{H}om_{\beta_X\mathscr{D}_X}(\beta_X\mathcal{M}, \mathscr{O}_X^t).$

We shall compare these two objects in a simple example in which \mathcal{M} is not regular. Let $X = \mathbb{C}$ endowed with the holomorphic coordinate z = x + iy and let $P = z^2 \partial_z + 1$. We consider the \mathcal{D}_X -module $\mathcal{M} := \mathcal{D}_X \exp(1/z) \simeq \mathcal{D}_X/\mathcal{D}_X \cdot P$.

Notice first that \mathscr{O}_X^t is concentrated in degree 0 (since dim X=1) and it is a sub-indsheaf of \mathscr{O}_X . It follows that the morphism $\mathcal{S}^t \to \mathcal{S}$ is a monomorphism. Moreover,

$$Sol(\mathcal{M}) \simeq \mathbb{C}_{X,X\setminus\{0\}} \cdot \exp(1/z).$$

It follows that for $V \subset X$ a connected open subset, we have $\Gamma(V; \mathcal{S}ol^t(\mathcal{M})) \neq 0$ if and only if $V \subset X \setminus \{0\}$ and $\exp(1/z)|_V$ is tempered.

Let \bar{B}_{ε} denote the closed ball with center $(\varepsilon, 0)$ and radius ε and set $U_{\varepsilon} = X \setminus \bar{B}_{\varepsilon}$.

Then one proves that $\exp(1/z)$ is temperate (in a neighborhood of 0) on an open subanalytic subset $V \subset X \setminus \{0\}$ if and only if $\operatorname{Re}(1/z)$ is bounded on V, that is, if and only if $V \subset U_{\varepsilon}$ for some $\varepsilon > 0$. We get **Proposition 3.4.1.** One has the isomorphism

(3.4.1)
$$\lim_{\varepsilon \to 0} \mathbb{C}_{XU_{\varepsilon}} \xrightarrow{\sim} Sol^{t}(\mathscr{M}).$$

Unfortunately, the functor Sol^t (as well as its derived functor) is not fully faithful since the \mathcal{D} -modules $\mathcal{M} := \mathcal{D}_X \exp(1/z)$ and $\mathcal{N} := \mathcal{D}_X \exp(2/z)$ have the same indsheaves of temperate holomorphic solutions although they are not isomorphic.

Proposition 3.4.1 has been generalized to the study of holonomic modules in dimension one in [Mr09].

3.5 Applications to \mathcal{D} -modules II

For $F \in \mathsf{D}^{\mathsf{b}}_{\mathbb{R}_{-c}}(\mathbb{C}_X)$, set (see (3.3.2)):

$$F \overset{\mathrm{w}}{\otimes} \mathscr{O}_{X} := \mathrm{R} \mathscr{H} om_{\mathscr{D}_{\overline{X}}} (\mathscr{O}_{\overline{X}}, F \overset{\mathrm{w}}{\otimes} \mathscr{C}_{X}^{\infty}),$$

$$thom(F, \mathscr{O}_{X}) := \mathrm{R} \mathscr{H} om_{\mathscr{D}_{\overline{X}}} (\mathscr{O}_{\overline{X}}, thom(F, \mathcal{D}b_{X})).$$

Let $F \in \mathsf{D}^{\mathsf{b}}_{\mathbb{R}\text{-c}}(\mathbb{C}_X)$ and $\mathscr{M} \in \mathsf{D}^{\mathsf{b}}_{\mathsf{coh}}(\mathscr{D})$. Recall that we have set $\omega_X^{\mathsf{hol}} := \Omega_X[d_X]$. Set for short

$$W(\mathcal{M}, F) := R \mathcal{H}om_{\mathscr{D}}(\mathcal{M}, F \overset{\text{w}}{\otimes} \mathscr{O}_X),$$
$$T(F, \mathcal{M}) := thom(F, \omega_X^{\text{hol}}) \overset{\text{L}}{\otimes}_{\mathscr{D}} \mathscr{M}.$$

There is a natural morphism

(3.5.1)
$$W(\mathcal{M}, F) \otimes T(F, \mathcal{M}) \to \omega_X^{\text{hol}},$$

functorial in F and \mathcal{M} . For $G \in \mathsf{D}^{\mathsf{b}}_{\mathbb{R}-\mathsf{c}}(\mathbb{C}_X)$ one gets a pairing

(3.5.2)
$$\operatorname{RHom}(G, W(\mathscr{M}, F)) \otimes \operatorname{R}\Gamma_{c}(X; G \otimes T(F, \mathscr{M})) \\ \to \operatorname{R}\Gamma_{c}(X; W(\mathscr{M}, F) \otimes T(F, \mathscr{M})) \\ \to \operatorname{R}\Gamma_{c}(X; \omega_{X}^{\operatorname{hol}}) \to \mathbb{C}.$$

Denote by $\mathsf{D}^{\mathsf{b}}(FN)$ the derived category of the quasi-abelian category of Fréchet nuclear \mathbb{C} -vector spaces and define similarly the category $\mathsf{D}^{\mathsf{b}}(DFN)$, where now DFN stands for "dual of Fréchet nuclear".

Theorem 3.5.1. ([KS96, Theorem 6.1]) Let $F, G \in \mathsf{D}^{\mathsf{b}}_{\mathbb{R}-c}(\mathbb{C}_X)$ and $\mathscr{M} \in \mathsf{D}^{\mathsf{b}}_{\mathsf{coh}}(\mathscr{D})$. Then the two complexes

RHom $(G, W(\mathcal{M}, F)) \in \mathsf{D}^{\mathsf{b}}(FN)$ and $\mathsf{R}\Gamma_c(X; G \otimes T(F, \mathcal{M})) \in \mathsf{D}^{\mathsf{b}}(DFN)$ are dual to each other through (3.5.2), functorially in F, G and \mathcal{M} .

Now we assume that $\mathcal{M} \in \mathsf{D}^{\mathsf{b}}_{\mathsf{hol}}(\mathcal{D}_X)$ and we consider the following assertions.

- (a) $W(\mathcal{M}, F) = R\mathcal{H}om_{\mathcal{Q}}(\mathcal{M}, F \overset{\text{w}}{\otimes} \mathcal{O}_X)$ is \mathbb{R} -constructible,
- (b) $T(F, \mathcal{M}) = thom(F, \omega_X^{\text{hol}}) \overset{\text{L}}{\otimes}_{\mathscr{D}} \mathcal{M}$ is \mathbb{R} -constructible,
- (c) the two complexes in (a) and (b) are dual to each other in the category $\mathsf{D}^{\mathrm{b}}_{\mathbb{R}_{-\mathrm{c}}}(\mathbb{C}_X)$, that is, $W(\mathscr{M},F) \simeq \mathsf{D}_X T(F,\mathscr{M})$.

It was conjectured in [KS03] that (b) is always satisfied. Based on the work of Mochizuki [Mo09] (see also [Ke10, Ke11, Sb12]), partial results in this direction have been obtained in [Mr10].

On the other hand, one deduces easily from Theorem 3.5.1 that (a) and (b) are equivalent and imply (c) (see [DS12]). Finally, it follows immediately from [Ka78, Ka84] that (b), hence (a) and (c), are true when $F \in \mathsf{D}^{\mathsf{b}}_{\mathbb{C}_{\mathsf{c}}}(\mathbb{C}_X)$.

Corollary 3.5.2. Assume that $F \in \mathsf{D}^{\mathsf{b}}_{\mathbb{C}^{\mathsf{-}c}}(\mathbb{C}_X)$ and X is compact. Then the complexes $\mathrm{R}\Gamma(X; W(\mathscr{M}, F))$ and $\mathrm{R}\Gamma(X; T(F, \mathscr{M}))$ have finite-dimensional cohomology and (3.5.2) induces a perfect pairing for all $i \in \mathbb{Z}$

$$H^{-i}R\Gamma(X;W(\mathcal{M},F))\otimes H^{i}R\Gamma(X;T(F,\mathcal{M}))\to\mathbb{C},$$

functorial in F and \mathcal{M} .

In [BE04], S. Bloch and H. Esnault prove directly a similar result on an algebraic curve X when assuming that \mathcal{M} is a meromorphic connection with poles on a divisor D. They interpret the duality pairing by considering sections of the type $\gamma \otimes \varepsilon$, where γ is a cycle with boundary on D and ε is a horizontal section of the connection on γ with exponential decay on D. Their work has been extended to higher dimension by M. Hien [Hi09].

In [DS12], we shall make a link with these results and Corollary 3.5.2.
